

Anchor Institutions and Economic Engagement



Jonathan Alger is president of James Madison University. He has previously served as senior vice president and general counsel at Rutgers University, assistant general counsel at the University of Michigan, and in legal and policy positions at the American Association of University Professors and the U.S. Department of Education's Office for Civil Rights. At Michigan, he helped lead the university's efforts in two landmark Supreme Court cases on diversity and admissions.

Alger is a nationally recognized scholar and speaker on higher education policy and law. He is past board chair of the National Association of College and University Attorneys, which honored him with Life Membership and the Distinguished Service Award. He has served on many national boards and committees, including the American Association of Colleges & Universities, American Council on Education, Campus Compact, and the Knight Commission on Intercollegiate Athletics. Alger is a graduate of Swarthmore College and Harvard Law School.

Cory Davies is the Executive Director for the RMH Foundation and serves a lead role in external partnerships at Sentara RMH Medical Center where he has worked for 14 years. A member of the Harrisonburg Rotary Club, Cory also enjoys serving on the Board of Directors for Explore More Discovery Museum. When he's not working, he enjoys running long distances, snowboarding, and attempting to surf ... all with his five kids.

Cory's prior experience includes work as an adjunct faculty member in James Madison University's School of Communication; as the Outreach Coordinator at the Collins Center in Harrisonburg, VA; and as an associate with M+R Strategic Services, a public affairs firm based in Washington, DC. Cory is the recipient of the Association for Healthcare Philanthropy's Top 40 under 40 award and the Shenandoah Valley Business Journal's Top 10 under 40. Melissa Lubin, Ph.D. is the Chief Economic Engagement Officer and Dean, School of Professional & Continuing Education at James Madison University. Amy Conrick is a Deputy Director at the Community Transportation Association of America, where she has worked since 2006. This includes assisting with their recruitment and training activities and supporting their efforts with funding from the Virginia Jobs Investment Program or services from the Virginia Talent Accelerator Program.

Dr. Johnson is currently serving on the Workforce Transformation Policy Council, a handpicked group of future focused workforce professionals who have an opportunity to inform federal policy and develop recommendations to better support a robust 21st century national workforce development system.

Housing



Dany Fleming is currently the Chair of the Harrisonburg Redevelopment and Housing Authority, which provides funding and housing for low-income families and residents and fosters redevelopment projects to ensure economic, social, and housing vitality in Harrisonburg. Dany has also served on and Chaired the Harrisonburg School Board and Harrisonburg Board of Zoning Appeals. Dany has worked for 35+ years, first in Chicago and now in Harrisonburg, supporting innovative education and community and economic development work. Among his previous work is with the Center for Neighborhood Technology, which was a national pioneer in both urban sustainability and innovative, affordable housing development, and The Civic Committee of Chicago, which authored Metropolis 2020, the plan for the Chicago region, including education, housing, transportation, and land use.

For more than a decade, **Ryan Price** has honed his knowledge of Virginia's housing market. Before stepping into his current role of Virginia REALTORS® Chief Economist, Ryan served as the association's Deputy Chief Economist. Prior to joining, he served as the President of research consulting firm LSA Planning, as an Urban Planner for the City of Alexandria, and as part of the research team at the Center for Regional Analysis at George Mason University. Before joining Virginia Association of REALTORS® full time, Ryan spent years contributing to the Association's research, including the monthly Virginia Home Sales Report and quarterly regional market reports. He holds a bachelor's degree in finance from James Madison University and a master's degree in urban planning from Virginia Tech.





Olivia Raines joined the Central Shenandoah Planning District Commission (CSPDC) in June 2021 and stepped into the newly created role of Housing Program Manager in November. Olivia is managing the recent \$2 million housing grant received from Virginia Housing, affording the CSPDC the opportunity to further facilitate regional housing initiatives, including the recently funded Regional Housing Study. Prior to joining the CSPDC, Olivia lived in Charlottesville where she worked for an affordable housing non-profit as a program coordinator, working with residents experiencing housing instability. This role cultivated a passion for housing advocacy which has carried her into her new role working on housing on a regional level. Olivia is an alum of the University of Virginia, and earned her Masters in City and Regional Planning with a concentration in Housing from The University of North Carolina at Chapel Hill.

Liz Web is the Housing Coordinator for the City of Harrisonburg. Originating this role, Liz is tasked with helping the city to achieve its vision of Available Housing For All. Guided by the 2021 Comprehensive Housing Assessment and Market Study, Liz has been researching funding opportunities and policies that will position Harrisonburg as a robust market for high quality affordable development and rehabilitation, and a partner in bringing programs to support homebuyers and renters to meet their housing needs. After starting her housing career in training and consulting, she has worked at state and local housing agencies in California and South Carolina. Most recently, Liz managed the Housing Choice Voucher program at the Harrisonburg Redevelopment & Housing Authority, where she administered over \$5 million in annual subsidy rental payments. She holds a Bachelor's degree from Smith College.


