Melissa Lubin is Dean of the School of Professional & Continuing Education at JMU where she oversees a continuum of learning including bachelor degree completion and certificate programs for working professionals, youth enrichment programs, and the Lifelong Learning Institute. Melissa also serves as the university's Chief Economic Engagement Officer where she navigates the university's fusion of economic development and community engagement.

Previously, Melissa was Virginia Tech's Director of the Commonwealth Campus Centers in Richmond, Newport News, and Virginia Beach. She is an ICF credentialed coach, a master practitioner of the MBTI and certified in the EQi assessment. Melissa also held leadership roles in the private sector, including the Apollo Group, Circuit City Inc., and This End Up Furniture.

Melissa earned a Ph.D. in Adult Learning and Human Resource Development from Virginia Tech, an MBA from Georgia Southern University, and a bachelor degree from Armstrong State College.

Jason El Koubi serves as VEDP's Executive Vice President, leading the organization's strategy and operations in collaboration with the President and CEO and directly overseeing activities related to economic competitiveness, international trade, incentives, research, and operations. Before joining VEDP in July 2017, El Koubi was President and CEO of One Acadiana, a regional economic development organization based in Lafayette, Louisiana. Under his leadership, the organization developed and launched one of the most successful capital campaigns of its kind in the nation to deliver a new economic development program for the nine-parish region. El Koubi also served as Assistant Secretary of Louisiana Economic Development, where he led initiatives that helped secure projects creating more than 63,000 new jobs along with more than \$28 billion in new capital investment, while dramatically improving Louisiana's position in virtually every state business climate ranking.

Jason has a B.S. in Biological Engineering from Louisiana State University and a M.S. in Public Policy from the London School of Economics.

Kathryn Crosby is the DEI and Health Equity Officer at the Virginia Department of Medical Assistance Services (DMAS) where she works to intentionally destigmatize Medicaid and promote health equity for the 1.9 million Virginians that are part of the Medicaid community. Additionally, she operationalizes diversity, equity, and inclusion within the agency by using organizational effectiveness paradigms to create inclusive workplace climate and culture. Prior to DMAS, Kathryn worked at a marketing-technology agency in Richmond where she led organizational DEI initiatives. She believes that diversity, equity, and inclusion have the ability to move our society forward towards something greater.

Kathryn received both her bachelor's and MBA from Averett University in Danville, Virginia. She earned her graduate certificate in Industrial & Organizational Psychology from Grand Canyon University and completed Cornell University's Diversity & Inclusion certificate program. Kathryn is currently pursuing her Masters in Human Relations with a concentration in Diversity, Equity, and Social Justice from the University of Oklahoma. Upon completion, she plans to continue using her knowledge and understanding of DEI to advance diversity, equity, and inclusion within organizations.

Renee Haltom is a Vice President and Regional Executive at the Federal Reserve Bank of Richmond. Her work involves engaging business, banking, and community leaders on national, regional, and local economic conditions to inform the monetary policymaking process, as well as sharing information about the Federal Reserve System. Haltom is based at the Richmond office and has responsibility for public outreach and engagement in Virginia, as well as for the Richmond Fed's Community Depository Institutions Advisory Council.

Haltom joined the Reserve in 2009 as an economic writer in the Research department, often with a focus on monetary policy, economic theory, and the Federal Reserve.

She most recently served as editorial content manager for the Research Publications team, and was editor of Econ Focus magazine from 2015 to 2018. She previously worked in the Research and Public Information departments of the Federal Reserve Bank of San Francisco, providing education on monetary policy and the Federal Reserve to a variety of audiences.

Haltom has a bachelor's degree in economics from Michigan State University and a master's degree in economics from the University of San Francisco.


