



## Recording Permissions Form | School of Music Students

Please read below, in detail, before signifying your agreement by signing & dating this document.

### Section One: Recording Permissions

By participating in performances under the auspices of the School of Music at James Madison University, you agree to have your performance recorded by James Madison University. While maintaining rights to its recording, James Madison University agrees to license the recording to you through a [Creative Commons Attribution-NonCommercial-NoDerivatives](#) license. In short, this means that you can use JMU's recording of your performance as long as the recordings are not changed nor used for commercial purposes.

### Section Two: Livestreaming/Recording Payment

Student performers who request a livestream/recording will be contacted by the operator **no earlier than two weeks up to five calendar days before the scheduled performance date**. Payment arrangements should be made between the operator and the student performer(s).

- For a Full Recital (~60 performing minutes), the total cost of the production is **\$30**.
- For a Half Recital (~30 performing minutes), the total cost of the production is **\$22.50**.
- For two combined Half Recitalists, both requesting service, their total/combined cost of production is **\$30**.
- In the event of technological issues occurring during the performance, including the livestream/recording, any payment distributed prior to the performance will be reimbursed by the operator, and there will be **no charge to the student performer**.
- Payments shall be made to the operator, in full, due **NO LATER THAN 24 HOURS** after the recital has concluded.

### Section Three: Specific Permissions

Audio will be recorded for ALL music performances in the Forbes Center for the Performing Arts. Major ensembles, all faculty recitals and chamber ensembles, and Doctoral recitals will be made a part of the School of Music Performance Collection in JMU Libraries. You have the additional options to permit video recording, livestreaming, sharing, and how your performance is made accessible by JMU Libraries.
